Students **must** use examination numbers and **not** their social security numbers **nor** any other numbers that they may wish to use.

If not taken using Examsoft (a program for laptop computer use), at the end of the examination, the examination administrator will check to see (by reference to a name/examination number sheet) that the student's number appears on the question sheet and on each blue book--if not, the student will be required to do so before the examination will be accepted. If the student does not have an examination number, the student will be required to accompany the examination administrator to the records office to obtain one after all other examinations have been turned in or the examination administrator may hold the examination while the student immediately goes up to acquire a number in the administrative suite.

Students will be able to use laptop computers with the Examsoft program to take exams in several courses. A list of those courses will be provided during the fall semester. If you take any exams on your laptop using the Examsoft program, the above paragraph applies with the exception that you will not be turning in blue books. You will be responsible for uploading your exam once the exam is complete. If you fail to upload your exam in a timely manner you will receive a failing grade for the course.

Courses not listed on the schedule will have take-home examinations without a specific date of distribution, or no final examination. The professors teaching the courses will provide further information.
