RESIDENCY

MISSOURI TAX SCHOLARSHIP

Students who are not Missouri residents and are assessed non-resident fees but work in Missouri and have a Missouri income tax liability, may be eligible for a partial Missouri Tax Tuition Scholarship. Students with visa types of J-1 and F-1 are not eligible. Medical students are not eligible. Applications are available from the Cashier's office, 112 AC, 5115 Oak and must be completed along with appropriate tax information.

FINANCIAL AID

Students who have Financial Aid equal to or greater than the amount owed will have fees paid by that aid. Students who have Financial Aid less than the amount owed will have to make the required payment in order for aid to be applied to fees.
